Academic Bank of Credits will digitally store the academic credits earned by students from HEIs registered with ABC for awarding degree/diploma taking into account credits earned by students. ABC facilitate students to choose their own learning path to attain a degree, working on the principle of multiple early-multiple exit as well as any-time, any-where and any-level learning.

In this regards, UGC notice dated 13th May, 2022 and GTU circular dated 6th March, 2023; it is mandatory for each enrolled student to generate his/her ABC id. Most of the students had generated their ABC id but yet few students had not generated their ABC id till date. As per the notice from UGC, students have to fill their ABC id while filling exam form.

It is instructed to students & affiliated institutes that GTU will imply to fill ABC id while filling their exam form from winter-2023.

Subject: Implementation of Academic Bank of Credits (ABC) on urgent basis

Respected Madam/Sir,

As you are aware, the Commission with the concurrence of Ministry of Education had notified "The University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulations, 2021" in the Gazette of India on 28th July, 2021. The Academic Bank of Credits (ABC) platform has been developed by the National e-Governance Division (NeGD) of Ministry of Electronics and Information Technology (MeitY) under DigiLocker framework, with facility/functionality of opening Academic Account by the students and on-boarding of Higher Educational Institutions (HEIs).

Academic Bank of Credits will digitally store the academic credits earned by students from HEIs registered with ABC, for awarding degree/Diploma /Certificates taking into account credits earned by students. ABC will ensure the opening, closure, and validation of Academic Bank of Accounts, verification, accumulation, and transfer or redemption for students. ABC facilitate students to choose their own learning path to attain a degree /Diploma /Certificates, working on the principle of multiple entry-multiple exit as well as any-time, any-where, and any-level learning.

To enhance the reach of the ABC programme, all Higher Educational Institutions are requested to take action on the following on urgent basis:

- Register your Institution on ABC (www.abc.gov.in).
- Upload data of Student Credits obtained during or after the academic year 2021-22.
- Make the students of your Institution aware about ABC facility and encourage and hand-hold them for opening Academic Bank Account on ABC portal (www.abc.gov.in).
- Create a hyperlink of ABC URL, i.e., www.abc.gov.in on your Institution's respective website's home page.
- Depute the Nodal Officers for implementing ABC and reflecting their details on their websites.
- Higher Educational Institutions may insist their students to fill up ABC id on all examination form.

This is to intimate you as per the reference mention above, the ABC (Academic Bank of Credit) registration of students are required to be implemented by all the GTU affiliated institutes immediately. In this reference, online meeting was conducted on 6th February, 2023 between 4.00 pm to 5.00 pm. In the meeting, it was discussed and suggested to carry out the registration of 2022-23 admitted students at the earliest by all the affiliated institutions.

It is further necessitated as per the NEP 2020 that the students who are admitted from the academic year 2021-22 and 2022-23 needed to register in the ABC.

In order to smoothen the process it is suggested that for each class, there will be one mentor who will take care of carrying out the above task at the earliest with the co-ordination of head of the Department/Principal/Dean/Director at respective institute. The Institute are also informed to appoint coordinator for Academic Bank of Credits and the Name, Contact No. , Email of the person should have to submit in the following form and also reflect onto Institute's website. .

The cumulative data of Students' ABC ID need to be submitted in GTU in the soft copy on Google form. The institute has to maintain hard copy of this data at the Institute Level. Link for the data submission is mentioned below:

This task must be completed at the earliest as it will going to be reflect in student's exam form and subsequently in the mark sheet / certificate which will be useful to the student once he/she wants to pursue multi-disciplinary courses.

The last date for submission of required data is 15/03/2023 (Softcopy).
