

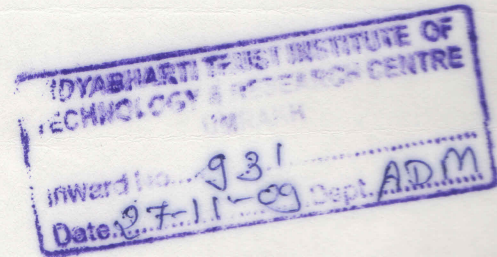
Please note that other terms & conditions in the earlier letter of even no dated 28.05.2008 will remain unchanged.
